# Description

The release notes are grouped by classification, with modules in the same order as the new menu for ease of reference. The menu path and specific menu names are indicated in *Italic*.

Some highlights featured in this release include:

An Unallocated Receipts (UNA) Register under Sundry Registers.

Payout options for Combined Invoice/Retention and Combined Invoice/Guarantee Project Invoices under *Creditors*.

Automatic Secondary Budget allocation for the Adjustment Budget process under *IDP* & *Budgeting*.

Bulk Impairment Reversal under Fixed Assets.

Consumer Debtors	Transactions > Payment Transfer Split An option has been added for a payment to be transferred to a Sundry Register.
Sundry Debtors	<i>Transactions &gt; Payment Transfer Split</i> An option has been added for a payment to be transferred to a Sundry Register.
Creditors	<i>Project Invoicing/Document</i> The search screen only lists Creditors that has budget allocated through Creditor Budgeting and Creditors added on a Contract.

General Ledger	<i>Journal Import</i> A password prompt has been added when importing a Last Year and Period 15 Journal.
	<i>Journal Enquiry</i> The VAT Consolidation Journals are listed without having to enter a specific Journal Number.



	<i>Project Enquiry</i> Columns have been added to the Excel extract to display the Creditor Code and Name.
	<i>Vote Enquiry</i> The Bulk Budget field has been added to the PDF document.
	<i>Reporting &amp; Extracts Menu &gt; GL Detail</i> A filter option per segment has been added for enhanced reporting functionality.
Procurement	Purchase Orders Create The Date Needed field has been added to the PDF document.
	Procurement Enquiry A column has been added to display the Tax Status of each Creditor listed.
Stores	Stock Sheets Print A column has been added to display the Bin Number.
	<i>Issue Enquiry</i> A column has been added to the Excel extract to display the Update Date of a Stores Issue.
	Reporting & Extract Menu > Stock Re-Order Report A column has been added to display the Bin Number.
	Reporting & Extract Menu > Deviation Extract A column has been added to display the Location.
Sub-Item Maintenance	Reporting & Extracts Menu > Vehicle Costs -Detailed and Summary Reports are available. PDF and Excel output options are available for the Detailed Report and an Excel output option is available for the Summary Report. -Columns have been added to display the Vehicle Description and the Function. -The Consumption is calculated as kilometres divided by litres

#### **Feature Requests**

Consumer<br/>DebtorsSystem Parameters > Rules & Defaults<br/>-A field has been added for 'Allow Transactions from Enquiries'<br/>on the Rules & Settings tab. If this field is ticked, a user will be<br/>allowed to do transactions from the Consumer Debtor Enquiry<br/>screen when expanding an entry on the Transaction Detail tab.<br/>-A field has been added for 'Mandatory Prepaid Meter Tariffs'<br/>on the Billing Setup & Rules tab. If this field is ticked, a Tariff<br/>Code has to be entered on a Pre-paid meter when created.



-A password prompt has been added for changes made to settings that will have a transactional impact on the billing. These settings include, under the Billing Setup & Rules tab: 'Current Financial Year Balances' 'Levy Indigents' 'Levy Inactive Accounts' 'Apply in Du Plum Rule'

System Parameters > Tariff Code Maintenance A field has been added for 'Meter Basic Charge' on the Tariff Maintenance screen so the Meter Rule can be applied per Tariff Code.

System Parameters > Meter Reading Types An option has been added for a user to indicate if/when a Reading Type can be overwritten by an imported Reading Type.

System Parameters > Reservoirs A new screen has been added to maintain Reservoirs information. The following Reports and Data Extracts has been amended to include Reservoir information: Levy Control Report Meter Reconciliation Report Meter Report Transactions Report Meter History Meter Master Transactions Extract Debtor Data Profiling

System Parameters > More Parameters > Query Category Maintenance

Additional categories have been added for 'Formal Dispute' and 'Informal Dispute'. This enables a user to categorise Queries or Notes according to their unique requirements.

Consumer Debtor Enquiry

-The number of New/Pending/Open Queries linked to a Debtor's Account is displayed.

-An 'Annual Proforma Tax Invoice' button has been added which enables the user to extract annual statements for Rates and Refuse when doing assessments.

-An 'Assessment Letter' button has been added which populates an Annual Rates and Service Assessment Notice.

-Inactive meters and Active meters linked to the same property is displayed on the Meters tab. The Inactive meters will be a different shade to be separated from the Active Meters.

-On the Credit Control tab, a dropdown on the Batch Number provides information on the specific batch. The 'Expand' button also provides more information on the specific Notes and

	<i>Meter Billing Enquiry</i> Enquiries can be done on disconnected meters that have not been reconnected to any accounts.
	Clearances > Clearance Costing -An option is available to select the current Levy Period for Clearance Costing calculations, which will base the calculation on the next billing values. If a past Levy Period is selected, the calculation will be based on the past billing values and if the current Levy Period is selected it will be based on current billing values. -Additional fields are available to accommodate Clearances with more than one buyer. The information is also displayed on the Draft and Authorised PDF documents.
	Reports > Transfer Ownership Report An option has been added for Capture Date to accommodate selecting a specific Date Range for transfers. This enables a user to check and compare deeds transfers for specified periods. Deeds Transfer information can be captured on <i>Erf Master</i> which will be displayed on all relevant reports. When capturing a Transfer of Ownership, the 'Transfer Date' is now a mandatory field.
Sundry Debtors	<i>Reports &gt; Movement Report</i> P13 Transactions are included at year end for both Detailed and Summary Report Types.
Sundry Registers	General A new Register for Unallocated Receipts is available. Receipts are captured and posted to the UNA Register from where it can then be transferred to the relevant account. This transfer needs to go through authorisation. A detailed register for Unallocated Receipts can be extracted for auditing purposes. Please refer to 'User Guide: Unallocated Receipts Register' for further detailed information.
Contract Management	Master File Maintenance A field has been added to indicate a No Value Contract. When transacting with this field ticked, there will be no Contract Budget Check, only a general Budget Check.
Creditors	Master File Maintenance A display field has been added for the 'Last Successful Sync Date' for the CSD Sync. It is also displayed on the PDF document.



	Project Invoice Capture Payout options for Combined Invoice/Retention and Combined Invoice/Guarantee has been added. This allows for the final Project Invoice to be combined with a Retention/Guarantee Payout, where previously two separate invoices (Project Invoice and Retention/Guarantee Payout) had to be captured. Information is displayed for the Project Invoice and for the Retention or Guarantee Invoices. The drop down that shows the Ret/Guar amounts still to be invoiced, will have a tick box to select the Retentions/Guarantees the user would like to pay out. When a combined invoice is selected it will populate the lines with the Ret/Guar Amounts and segments and then the user can allocate the Invoices are selected, the different lines from all Invoices selected will be auto populated.
	Reporting & Extracts Menu > Creditors Audit Report An extract to list the consolidated CSD Sync details.
Fixed Assets	Impairments Import Impairments may be reversed in bulk by means of an Import. It is limited to the amount necessary to restore the asset to its pre- impairment carrying amount, less any subsequent depreciation or amortisation that would have been recognised (i.e. based on the asset's pre-impairment depreciated/amortised carrying amount). To reverse the impairments, select the Impairment Reversal option and indicate the Transaction Period.
Procurement	Requisition Capture/Resume -A notification has been added to inform a user when capturing for a Creditor of which the Tax Clearance Certificate has expired. -An Incl/Excl field has been added to indicate if the Price Captured is inclusive or exclusive of VAT.
	Delivery Note Capture (Only applies when utilising the Delivery Note System) When an invoice is captured against a Purchase Order, the Quantity Delivered will only be updated to Quantity Invoiced once the Invoice has been authorised. Only once the full quantity ordered has been invoiced and authorised, or once the Order has been Closed, will the order be removed from the items listed on the search screen.
IDP & Budgeting	ADJB Control Create The Adjustment Budget process accommodates Automatic Secondary Budget allocation based on the Primary and Secondary alignment as allocated in the Budget Item Control screen under System Parameters > General Ledger.



	This automatic allocation has a two-fold activation, first being the activation of the item within the parameter and secondly the activation of the Secondary Budget allocation when running the Control for Adjustment Budget as part of the Forecast process. The Auto allocation may be cleared by rerunning 'ADJB Control Create' and not flagging the option for "Create Secondary Records".
Registers	Petty Cash Take On Amount Capture When changes are made to the document, before authorisation, a PDF document with updated information is populated.
Stores	<i>Stock Enquiry</i> A PDF output option is available when a user clicks the dropdown on Document No.
	Reporting & Extracts Menu > Stock Movement Report A selection option per Period is available.
Finance Administration	Operator Departments Assign A selection field for Status has been added after which an Excel extract can be generated displaying all users with the selected Status. If the Status is selected for All and an Operator is selected, another selection field for Functions is available.
ICT Administration	<i>Operator Movements</i> A selection field for Role has been added and is also displayed on the Excel output option.

Management	The Military Veterans option has been added.

*Quotation Capture* The program will auto allocate points based on the SCM Criteria Setup for B-BBEE Levels Allocation.

## Operational

Cashiers	Receipt Integration > Direct Deposit/Third Party File Import Credit values are rejected when imported.
Creditors	<i>General</i> Additional checks have been added to the program to ensure that a duplicate invoice number per Creditor can't be captured.

Monthly Procedures	Month End Authorise -Cosmetic changes have been applied to accommodate the process flow of month end procedures. -Petty Cash transactions have been added to the month end checks. Cash Book month end can only be completed if all Petty Cash transactions have been authorised.
